In the circumstances reported by the Chief Executive Officer, Society for Elimination of Rural Poverty (SERP), A.P. Vijayawada, in the reference 3rd cited and after careful examination of the matter, the Government hereby accept the following revised time lines, for work flow duly incorporating re-verification process keeping in view of extending the scheme of "**YSR Cheyutha**" to YSR Pension Kanuka Pensioners:-

**"YSR CHEYUTHA" FINALIZATION OF THE BENEFICIARIES RE-VERIFICATION
WORK FLOW FOR THE IMPLEMENTATION**

Step: 1

Mobile app modules screens and voice over video development by CFSS for ineligible beneficiary data re-verification.

STEP:2

Training on SOP (Standard operational procedure) to the MPDOs and Municipal commissioners, welfare & Education Assistant (WEA) Ward welfare & Development secretaries (WWDS) on ineligible beneficiary's re-verification process through mobile app.

Step:3

Welfare & Education Assistant (WEA) Ward welfare & Development secretaries (WWDS) on ineligible beneficiary's re-verification process through mobile app.

Update the field observations against each parameter and upload mandatory documents in the WEA/WWDS login and submit to MPDOs/Municipal Commissioners login.

Preparation of Final List Draft eligible/ineligible lists were placed in the notice board of Secretariat for Social Audit. Receive grievances.

Time - Line: 27.07.2020 to 29.07.2020

Step: 4

Scrutiny of application-Scrutiny of applicant details, documents attached departmental validation remark and field observations of WEA/WWDS with reference to scheme guidelines and eligible criteria shown in Annexure and accepts or rejects the application.

The MPDO/MCs will finalise the list and sent to the District level Executive Directors of the concerned Corporations

Time - Line: 30.07.2020 to 03.08.2020

Step: 5

Finalization of lists by MPDOs/Municipal Commissioners and forward the same to respective District Level Executive Directors of BC, SC, ST & Minority Corporations

Time - Line: 04.08.2020 to 06.08.2020

Step: 6

Receiving of approved data from all districts corporations through online by SERP. Approved list shall be referred to CFMS.

- Preparation of Corporation wise requirement of budget
- Submit Proposal to Finance for adjustment of funds to corporation PD A/c.
- Validation of Beneficiary Bank Accounts.
- Display of final eligible list in A3 size at Village/Ward Secretariats.
- Preparation of bills in CFMS
- Issue of sanction proceedings for release of funds
- Approval of Bills by MDs of Corporations

Time - Line: 07.08.2020 to 10.08.2020

Step:7

Launching of the YSR Cheyutha Scheme by the Hon'ble Chief Minister

Transfer of amount to the Beneficiaries Bank Accounts through DBT from CFMS.

Time - Line: 12th August, 2020
